## **RESOLUTION NO. 2-2011-23**

RESOLUTION OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN AND STATE OF NEW JERSEY, ASKING PRESIDENT OBAMA TO MAINTAIN CURRENT FUNDING LEVELS FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

**WHEREAS**, we understand that discussions are taking place within the Obama Administration regarding a substantial reduction in spending for the Community Development Block Grant program in preparation of the FY2012 budget; and

**WHEREAS**, some reports have indicated that a cut of 25%, or \$1 billion dollars is under consideration; and

**WHEREAS**, this, or any reduction in funding for CDBG projects would have a devastating impact on the Borough of Barrington and would hinder our ability to continue doing our part in aiding the Nation's economic recovery; and

**WHEREAS**, specifically, a 25% reduction in funding would mean curtailing or cancelling the following projects that are planned for the Borough of Barrington;

- Construction of curb cuts throughout our town for handicapped access
- Providing of transportation for senior citizens
- •Improvements to the Barrington Senior Center

WHEREAS, the ability to complete these projects not only provides valuable services to our senior and handicapped population but also has a positive economic impact in that it results in contracts being awarded to the construction and related industries; and

**WHEREAS**, over the years, the following projects have been completed in the Borough of Barrington using CDBG funds:

- Construction of the Barrington Senior Center
- •Removal of architectural barriers in the Barrington Community Center
- Construction of curb cuts for handicapped access

**WHEREAS**, these projects have been funded through the CDBG program and have provided a direct benefit to our low and moderate income residents and their neighborhoods, something that would not have been possible without this federal-local partnership;

**NOW, THEREFORE,** Mr. President, we strongly urge you in your FY2012 budget to freeze CDBG formula funding at the FY2010 level of \$3.9 billion dollars so that we may continue to improve the quality of life for our low and moderate income, senior citizens and handicapped residents and so that we may also continue to contribute to the recovery of our local economy.
